

**Maple Grove Parks and Recreation Board**

**APPLICATION FOR REDUCED RECREATION PROGRAM FEE**

The Maple Grove Parks and Recreation board, with the assistance of civic groups and organizations, has a limited amount of resources set aside to grant scholarships for children to participate in recreational activities. Scholarships are granted according to the reduced price eligibility income table and are subject to the following conditions:

1. Scholarships will be granted only if funds remain in this account.
2. Applicants must be residents of the City of Maple Grove.
3. Applicants may receive a reduced fee only once during the same year.
4. Funding will be awarded for 1/2 the program fee per child (not to exceed \$100.00) one program per child per year.
5. Applications will be accepted for children's activities only (18 years or under).
